Steve Sopocy gave updates with the County. Wind Turbines are done in Gratiot County. There is a FOIA involving the first turbines installed by Breckenridge & Wheeler area. The County may have some money for townships to ask for from the ARPA funds. Requests are to be sent to Chris Osteroff, County Administrator. All money is to be spent by December 2025.

Minutes by Clerk Tamey Skinner for October 14, 2024 monthly meeting were emailed to Board members. Tyler Moomey made motion to accept minutes. Chris Bovee seconded. Motion carried.

Treasurer Report – Ending balance for October 31, 2024 was \$95,309.02. Tessa Zuker emailed a list of bills to be paid for November 2024. Tessa Zuker made a motion that November bills be paid. Motion seconded by Tyler Moomey. Motion carried. FDIC Program has been started through Commercial Bank.

Election had a few mechanical problems but all were fixed. There are 720 registered voters in Newark Township. The amount of voters was 416 (absentee ballots and hall voting) along with 115 for the early voting at the County site in Ithaca. Total of 531 voters for the General Election of 2024.

CMS Support Team will put a Camera App for the security cameras on Katie Cooper's phone.

Land Division – John & Lori Misenhelder parcel #2908-033-012-12. Two acres to be split along with .57 acres for a driveway. Total of 2 ½ acres. Tyler Moomey made a motion to accept the land division. Chris Bovee seconded. Motion carried.

This Property will now be presented to the Gratiot County Zoning Committee for approval for the Road and Property Variance of this property.

The Oath of Office for all members of our Board was done at November 11, 2024 meeting by Clerk Tamey Skinner. New officers take over November 21 at noon.

Drain At Large decision to pay part or all the amount due will be tabled until the December meeting.

Grant Road is finished for the Winter with 2 $\frac{1}{2}$ inches of asphalt and gravel sides. In the Spring, 1 $\frac{1}{2}$ inches will be added and extended to Luce Road from Alger to even the pavement.

New email addresses will be assigned to the Supervisor, Clerk & Treasurer. Julie Braun will get all set up. Cost of Hosting the Website is \$400.00 per year and \$60.00 for maintaining and adding minutes, photos, calendar ect. No fee for training to main website and then the Board can maintain it.

CMS Fiber permit was granted through Newark Township on Washington Road.
